### What's New at CTC?

### **New Policies**

At their September meeting, the CTC Board adopted two new policies for the protection of both our passengers and employees—the Wheelchair Use Policy and the Package Transport Policy.

Wheelchair Use Policy

We strive for the safe transportation of all passengers to and from Chebeague. Crew members will make every reasonable effort to help those passengers who need to be transported on or off the ferry in a wheelchair. However, there may be times when the captain of the ferry deems it unsafe for a crew member to transport a passenger up or down the ramp due to stormy weather, steep angle of the ramp, icy conditions, etc. At those times, the captain may deny passage to a passenger in a wheelchair due to concerns for the personal safety of either the

crew member or the person in the wheelchair.

Package Transport Policy

It is the Policy of the Company to transport packages both on and off the island as a service and convenience to our customers. Customers requesting package transport by ferry boat or bus will be responsible for assuring proper packaging of contents and labeling for delivery, as well as making arrangements for delivery or pickup. All packages transported by the Company shall be carried at the customer's risk, and the Company shall have no liability for lost or damaged packages or their contents. Normal freight fees apply.

#### 2014 Parking

## Commuter Parking Starts 11/1

Every year from November 1st to March 31st we designate a "commuter parking" area in the Cousins lot. This is reserved for persons commuting to the mainland Monday-Friday at least 3 days per week. The purpose is to improve our snow removal ability. Commuters will be given a special sticker on their permit.
